


When fastening metal hose clamp, recommended torque value 1.5N/M, over-tightening might result in deformation or crack.


















Secure the solenoid to any area in the engine bay, take note that the length of pipe B to the variable filter should not exceed 30cm












EXARIABLE AIR INTAKE
